- Call to Order & Roll Call Brian Johnson
 Brian Johnson, Chair, called the meeting to order. A quorum was present.
- 2. Approval of the Agenda
 A motion to approve the agenda was made by Travis Fleshner. Second by Darwin
 Lehmann. Approved unanimously.
- 3. Approval of Meeting Minutes from 06/23/2020

 A motion to approve the minutes of the 6/23/2020 meeting was made by Travis
 Fleshner. Second by Darwin Lehmann. Approved unanimously.
- 4. Regulatory Update Margaret Buckton
 Margaret Buckton shared there was nothing new to report on the regulatory front at this
 time. The group discussed that this program provides needed flexibility for schools,
 especially in the time of COVID-19, as well as this being an excellent example of local
 control decision making.
- 5. Participation/Marketing Update Jen Albers & Don Krattenmaker

 Don Krattenmaker & Jen Albers shared that LGRP program marketing efforts continue.

 Discussion ensued.
- 6. Approval of Application & Agreements to Join the 28E, and Participation Agreements Jen Albers shared the list of districts that have completed the Application to Join the 28E as well as a listing of Participation Agreements for 2020-21, for approval by the Board.

A motion was made by Darwin Lehmann to approve the pending Application to Join the 28E. Seconded by Travis Fleshner. Approved unanimously. A motion was made by Travis Fleshner to approve the pending Participation Agreements for 2020-21. Seconded by Darwin Lehmann. Approved unanimously.

- 7. Iowa LGRP Financial Report Jen Albers & Jon Muller
 Jen Albers shared the YTD Financial Report for the Iowa LGRP 28E, showing a deficit of
 approximately \$6000 for the first year of the entity. Jen also shared preliminary draft FY
 2020 loss ratio reports from the service providers, noting some invoices remain
 outstanding. Discussion ensued about issuing refunds to FY 2020 participants after the
 September meeting. A motion was made by Travis Fleshner and seconded by Darwin
 Lehmann to direct staff to prepare reports calculating final refunds due to FY 2020
 participants (based on the previously approved formula) immediately after approval at
 the September 30th meeting, based upon the premiums refunded from the service
 providers less \$15,000 to be retained by Iowa LGRP to cover administrative expenditures.
 Approved unanimously.
- 8. Other Business/Adjourn

There being no other business, Travis Fleshner moved to adjourn and Darwin Lehmann seconded. Approved unanimously. Meeting adjourned at 1:43 pm.
