#### 4. Regulatory Update – Margaret Buckton & Jen Albers

Jen Albers and Margaret Buckton shared that no new guidance has been issued from any regulatory authority with regards to this program. Jen shared that a couple of districts had reached out to the DE to ask if new guidance had been issued around this program, and received a response that the DE had not changed their guidance. The State Auditor's Office continues respond to local auditors with their original guidance. Again, all first year program participants received clean audited financial reports from their local school auditors, and none had CAR changes, with respect to this program. A couple of schools told us that their local school district auditors did a significant review of the program as part of their audit to ensure they agreed with the opinion of the State Auditor's Office, and also concluded it should qualify as a valid use of Management Funds.
