- 1. Call to Order & Roll Call (and welcome to Travis Fleshner) *Brian Johnson Brian Johnson, Chair, called the meeting to order at 12:03 pm. A quorum was present.*
- 2. Approval of the Agenda
  A motion to approve the agenda was made by Russ Reiter, seconded by Travis Fleshner.
  Approved unanimously.
- 3. Approval of Meeting Minutes from 3/29/2023

  A motion to approve the minutes from 3/29/2023 was made by Russ Reiter, seconded by Travis Fleshner. Approved unanimously.
- 4. Regulatory Update Margaret Buckton & Jon Muller Margaret Buckton shared that no new guidance has been issued from any regulatory authority with regards to this program.
- 5. Market Update Don Krattenmaker & Athena Simpson
  Athena Simpson provided an update on the overall natural gas markets, exports, and pricing, and reviewed the charts included in the board packet.
- 6. Participation/Marketing Update Jen Albers & Athena Simpson
  Jen Albers and Athena Simpson shared a marketing report on the status of renewals and
  new participants for FY 2024. Discussion took place around other marketing activities.
- 7. Approval of Agreements
  - Application & Agreements to Join the 28E
  - Participation Agreements

Jen Albers shared the list of new districts that have completed the Application to Join the 28E along with FY 2024 contracts received to date, for approval by the Board.

A motion was made by Russ Reiter and seconded by Travis Fleshner to approve the pending Applications to Join the 28E as well as the pending Participation Agreements for 2023-24, as presented. Approved unanimously.

# 8. FY 2023 YTD Financial Report – *Jen Albers*

Jen Albers shared the YTD Financial Report through April 30, 2023 for the Iowa LGRP 28E. A motion was made by Travis Fleshner and seconded by Russ Reiter to approve the YTD financial report through April 30, 2023. Jen mentioned there will be several FY 2023 participation agreement amendments for districts with construction in progress, and these will be presented at the upcoming meeting. Discussion ensued. Approved unanimously.

## 9. Approval of Budget for FY 2024

Jen Albers reviewed the proposed FY 2024 Iowa LGRP Budget based on the assumption that all current participants we have not yet heard from will renew and including all new participants we have received to date. A motion was made by Russ Reiter to approve the FY 2024 Budget as presented. Seconded by Travis Fleshner. Discussion ensued. Approved unanimously.

At the previous meeting, Russ Reiter notified the LGRP Board that he will be retiring from Independence CSD, and this will be his final meeting. Russ Reiter moved approval to reappoint Brian Johnson as Chair and Darwin Lehmann as Vice-Chair, and to appoint Travis Fleshner as Secretary/Treasurer for FY 2024. Seconded by Travis Fleshner. Approved unanimously.
